Beginning at a point on the South line and One Hundred Twenty-five and Seventy-six One-Hundredths (125.76) feet from the Southwest corner of Lot fourteen (14), Block Two (2), Sunset Terrace Addition to the City of Tulsa; thence North Twenty-five (25) degrees and Thirty-five and Seventy-six One-Hundredths (35.76) minutes East a distance of Eighty-six and Forty-two One-Hundredths (86.42) feet; thence on a curve to the right with a radius of One Hundred Fifteen (115) feet a distance of Eleven and Twenty One-Hundredths (11.20) feet to a point on the North line and One Hundred Forty-five and Fifty-six One-Hundredths (145.56) feet from the Northwest corner of said Lot fourteen (14).
