A strip of ground, not to exceed ten (10) feet in width on either side of the center line of said sewer line, as shown by the blue prints on file in the City Engineer's office of the City of Tulsa, the center line of said Twenty (20) foot strip, being more particularly described of follows, to-wit:

Beginning at a point on the line between lot ten (10) and eleven (11) Block two (2) in Acre Gardens Addition to the city of Tulsa, Tulsa County, Oklahoma, thirty-one (31) feet west of the south-east corner of said lot ten, thence north a distance of ninety-two feet
