Beginning at a point on the South line of Lot 14, Block 1, Park Dale Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof, said point being a distance of 154 feet from the Southwest corner of said lot; thence to a point on the North line of said lot, said point being a distance of 149 feet from the Northwest corner of said lot.
