DEED OF TRUST.

THIS DEED, Made and enter d into this 10th day of September, 1924, by and between L. Stovall and wife, Mamie Stovall, and Thos. C. Sheppard and wife, Mabel E. Sheppard. of Tulsa, Okla, parties of the first part, and M. Hughes, Trustee, party of the second part, and the CENTRAL SAVINGS AND LOAN ASSOCIATION, of Marshall, Missouri, party of the WITNESSETH, That the said parties of the first part, in consideration of the debt and trust hereinafter mentioned and created and the sum of One Dollar to them paid by the party of the second part, the receipts of which is hereby acknowledged, do by their presents, Grant, Bargain, Soll, C nvey and Confirm unto the said party of the second part, the following described Real Estate, situated in the County of Tulca, and State of Oklahoma, to-wit: The Bast Forty five (45) feet of the West Ninety (90) feet of Lots Thirteen (13) and Fourteen (14), in Block Four (4) Bossells Addition to the City of Tulss, and Certificate number 925 being for 8 1/8 share of "D" stock in the CENTRAL SAVINGS AND LOAN ASSOCIATION, of Marchall, Missouri, and possession of said promises and said shares of stock is now delivered unto the said party of the second_part.

TO MAVE AND TO HOLD the same with all the rights and appurtenances there to belonging to the said party of the second part and to his succe sor hereinafter designated, and to the ascigns of him and his successor, forever.
