THIS AGREEMENT OF LEASE made and entered into this 4th day of August, 1924, by and between Sand Springs Home, an Oklahoma Corporation of Sand Springs, Oklahoma party of the first part and AMERICAN GLYCERIN COMPANY, a corporation, party of the second part:-

WITNESSETH: That for and in consideration of the sum of One Hundred (\$100.00) dollars to it in hand paid, the receipt whereof is hereby acknowledged, the party of the first part does hereby grant and lease unto the party of the second part for a period of one year from date hereof with the privilege to renew from year to year at option of the party of the second part not to exceed in all a term of five years, the exclusive right and privilege to erect and maintain a storage magazine for the storage of nitroglycerin and
