DECREE CONFERRING RIGHTS OF MAJORITY

This matter came on to be heard before me A. S. Wells Judge of the District Court in and for Oklahoma County, Oklahoma, this 24th day of March, 1923, on the application and petition of Simon Karl Bean, by his next friend, Mrs. Lotta Mosier, to have the rights of majority conferred upon the said Simon Karl Bean, a minor, and it appearing to the court that due and legal notice of this application has been given by publication for two consecutive weeks prior to presenting this application in a newspaper printed in said County and State, and the court having heard the evidence in open Court, finds that said petitioner is of the age of twenty (20) years; that he is of sound mind and fully able and competent to transact his own affairs and that the interests of said petition will be materially promoted by granting the prayer of said petition, and that said Simon Karl Bean has been an actual resident of this state for one year next preceding the filing of said petition, and is at present a resident of Oklahoma County.

It is therefore adjudged, ordered and decreed by the court, in pursuance of the authority conferred by section 8099, Compiled Oklahoma Statutes, 1921, that the rights of majority concerning contracts be, and the same are hereby, conferred upon said Simon Karl Bean, and said Simon Karl Bean is hereby authorized and empowered to transact business in general with the same force and effect as if such business were transacted by a person over the age of majority.

FINAL DISCHARGE.

IN THE COUNTY COURT OF OKLAHOMA COUNTY, STATE OF OKLAHOMA

In the Matter of the Estate of Simon Karl Bean, a Minor, No. 5375.

Sarah E.
