

THAT, WHEREAS, under an agreement between Chas. Page, E. R. Minshall, J. F. Sweeney and R. N. Koblegard, dated February 14th, 1912, the last named three persons being parties of the second part in said contract, it was recited in said contract that said Chas. Page agreed to carry said second parties for a one-quarter working interest in the net oil derived from the tracts of land in said agreement, which tracts included the Southwest Quarter of the Southwest Quarter of Section 5, Township 19 North, Range 12 East, Tulsa County Oklahoma, being the land covered by the assignment of the lease this day made by the Mary Oil & Gas Company, a Corporation, to Thompson & Black, a Corporation.

NOW, THEREFORE, it is mutually agreed that the General Warranty set out in said assignment of said lease and running to said Thompson & Black, a Corporation, shall as to the working interest of said Minshall, Sweeney and Koblegard in the land heretofore described apply to, and cover only one-quarter of the purchase money paid and agreed to be paid by Thompson & Black, Incorporated, to the Mary Oil & Gas Company, under and by virtue of the term of this assignment,

It being intended by this limitation upon the foregoing General Warranty to hold said Thompson & Black, Incorporated, harmless against any claim which said Minshall, Sweeney and Koblegard might assert against it under said working interest agreement, aforesaid, to the extent only of one-quarter of the purchase money, aforesaid, of said lease assignment.
