First part, was appointed Special Master to make the sale of the property therein provided for and hereinafter described; and,

Thurman, as such Special Master, as aforesaid, for and in consideration of the premises, and of the sum of Twenty-two Thousand Eight Hundred Seventy-five and no/100 (\$22,875.00) Dollars, paid in accordance with the terms of the said decree, has granted, bargained, transferred, sold and conveyed, and by these presents does hereby grant, bargain, transfer, sell and convey unto the said Edward L. Fairbanks, the following described lands located in Tulsa County, State of Oklahoma, to-wit:
