of One Dollar to us in hand paid, and of other good and valuable considerations, the receipt
of which is hereby acknowledged, we, W. H. Dunlap and Claudia Dunlap, husband and wife, and
B. H. Ball and Mary D. Ball, husband and wife, of Siloam, Springs, Benton Co., Ark, do hereby
assign and set over to M. Hughes, Trustee for the Southwestern Mortgage Company of Roff,
Pontotoc County, Oklahoma, all rentals profits and emoluments accruing to or arising from the
following real estate situated in the County of Tulsa, and State of Oklahoma, to-wit: Lots
