WHEREAS, at the regular meeting of the Commissioners of the Land Office of the State of Oklahoma, held June 17th 1913, the following resolution was adopted: "Be it resolved, that the Secretary to the Commissioners of the Land Office of the State of Oklahoma, be and he is hereby authorized to accept payment of any mortgage and the debt secured thereby made to the Commissioner of the Land Office of the State of Oklahoma, and upon such payment having been made, the Chairman and the Secretary to the Commissioners of the Land Office of the State of Oklahoma, on behalf of the Commissioners be and they are hereby authorized and empowered to execute good and sufficient release to the proper parties therefore. All vote "AYE" Motion prevailed.

WHEREAS, Payment in full having been made on said note.

NOW, THEREFORE, Under and by virtue of the above resolution, the Commissioners of the Land Office by their Chairman and Secretary for and on behalf of the State of Oklahoma, in consideration of value received, do hereby acknowledge full payment and complete satisfaction of the mortgage above described, and do hereby release and discharge said land from the lien of said mortgage.
