

southeast twenty acres of Section 14, Township 18 North, Range 13 East, remaining after the payment of my just debts, shall be divided equally between my three sons, Will Scheer, Rudolph Scheer and Adolph Scheer.

Sixth. I give all the remainder of any monies that I may have at the time of my death to my three sons, Will Scheer, Rudolph Scheer and Adolph Scheer, each one to receive one third.

Seventh. I hereby constitute and appoint F. S. Hurd, Executor of this, my last will and testament, and direct that no bond or security be required of him as executor.

Eighth. It is my will that no other action shall be had in the County Court in the administration of my estate, than to prove and record this will and to return any inventory and appraisement of my estate and list of claims.

IN WITNESS WHEREOF, I. H. Scheer, have to this my last will and testament consisting of one sheet of paper, subscribed my name this 26th day of August, A. D. 1922.
