advanced to the said Clayton De Vere McConnell and Dorcas Lucile McConnell; and it is further ordered that the said Josephine McConnell Hood, her heirs, representatives and assigns, shall take her one-third (1/3) interest in the lands last hereinbefore described, subject to the claims of the said Clayton De Vere McConnell and Dorcas Lucile McConnell, against said one-third (1/3) interest, in the amount of \$1,100.00 each.

It is further ordered that the interest in said lands herein distributed to the said Josephine McConnell Hood, subject to the said charges, be set over to the said Francis L. Thompson, as executor of the last will and testament of the said Josephine McConnell Hood, deceased.

It is further by the Court ordered, adjudged and decreed, that from the money belonging to said estate in the hands of said administrator, be paid the court costs and attorneys fees incident to winding up and closing this estate and that said administrator pay to the said Clayton De Vere McConnell, one-third (1/3) thereof, and that the remaining one-third (1/3) held by the credit of Josephine McConnell Hood estate be paid to the said Clayton De Vered McConnell and Dorcas Lucile McConnell, in equal parts as credits on said claims of \$1,100.00 each, held by the said Clayton De Vere McConnell and Dorcas Incile McConnell, as aforesaid.
