of \$150.00 dollars, or such different sum as may be provided for by said note which shall be due upon the filing of the petition inforeclosure and which is secured hereby, and which the first party promises and agrees to pay, together with expense of examination of title in preparation for foreclosure. Any expense incurred in litigation or otherwise, including attorney fees and abstract of title to said premises incurred by reason of this mortgage or to protect its liens, shall be repaid, by the mortgagor to mortgagee or assigns, with interest thereon at 10 per cent per annum, and this mortgage shall stand as security therefor.
