

manner and for the time in such cases required by laws.

And it appearing to the Court that said final account is in all respects true and correct, and supported by proper vouchers; that the residue remaining in the hands of the executrix amounts to thirty five and 18/100 (\$35.18) dollars; that the estimated expenses of closing the estate will amount to about that amount, leaving no money in the hands of the executrix of said estate belonging to said estate.

And it appearing that all claims and debts against said decedent, all taxes on said estate, and all debts, expenses and charges of administration have been fully paid and discharged, and that the terms of said will and the orders of this court have been fully complied with by said executrix, and that said estate is ready for distribution and in condition to be closed.

It is ordered, adjudged and decreed by the Court that said final accounts of said executrix be and the same are hereby settled, allowed and approved, and that the residue of said estate, hereinafter particularly described, and any of the property not now known or discovered, which may belong to said estate, or in which said estate may have an interest, whether real, personal or mixed, be distributed to Pencie B. Hayter, and to her heirs, executors, administrators and assigns forever, to-wit:

All of the following described real estate lying and being situate in Tulsa County, State of Oklahoma, to-wit:

The north half ( $N\frac{1}{2}$ ) of lot one (1) in block one hundred thirty three (133) of the original town of Tulsa, said County and State,

All of the following described real estate lying and being situate in Pontotoc County, State of Oklahoma, to-wit:

The north half ( $N\frac{1}{2}$ ) of the southwest quarter ( $SW\frac{1}{4}$ ) of the northwest quarter ( $NW\frac{1}{4}$ ) and the northwest quarter ( $NW\frac{1}{4}$ ) of the southeast quarter ( $SE\frac{1}{4}$ ) of the northwest quarter ( $NW\frac{1}{4}$ ) of section six (6) township four (4) north, range eight (8) east, said County and State

All the following described real estate lying and being situate in Marshall County, State of Oklahoma, to-wit:

The south half ( $S\frac{1}{2}$ ) of the southeast quarter ( $SE\frac{1}{4}$ ) of the northwest quarter ( $NW\frac{1}{4}$ ) and the southeast quarter ( $SE\frac{1}{4}$ ) of the southwest quarter ( $SW\frac{1}{4}$ ) of the northwest quarter ( $NW\frac{1}{4}$ ) of section thirty four (34) township five (5) south, range seven (7) east, said county and State.

All of the following described personal property, consisting of six (6) promissory notes for one hundred and 00/100 (\$100.00) dollars each, executed by Walter French Scott and Ora Arnold Scott, and payable to Lock H. Hayter,

All of the following described personal property, consisting of United States Liberty Bonds in the sum of twelve hundred and 00/100 (\$1200.00) dollars.

And any and all other property, not now known or discovered, whether real, personal, or mixed, which may belong to said estate, or in which the estate may have an interest.
