Affiant further states that there has never been any development upon any of the above set forth leases at any time since the execution of same, nor has affiant ever consented to the extension of the time of said leases, nor has there ever been any rentals paid upon any of said above set forth leases since their execution to this date.

Affiant hereby declares a forfeiture of all rights and privileges under and by virtue of said above set forth leases, and declared same to be null and void, as having lapsed by the terms and conditions of said lease above set forth, and by reason of non-development and non-payment of rentals, upon same since their execution as above set forth.
