OIL AND GAS LEASE.

AGREEMENT, Made and entered into onthis 8 day of December, 1924, by and between W.F.Ellsworth and Ella Ellsworth, and Will Butcher and Margaret J. Butgher, parties of the first part, hereinafter called lessors, and mEdward Yoder, party of the second part, hereinafter called lessee.

WITNESSETH: That the mid lessors for and in consideration of the sum of one dollar (\$1.00) wash inhand paid, receipt of which is hereby acknowledged and of the ovenants and agreements hereinafter contained on the part of the lessee to be paid kept and performed, have granted demised, leased, and let, and by these presents do grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and may and laying pipe lines, and building tanks, powers, statims and structures thereon to produce, save and take care of products, all that certain tract of land situate in the County of Tulsa, State of Oklahoma, described as follows, to-wit:

The north half (N2) of the northeast quarter (NE1) of section 18, township 17 north, ramge 13 east, containing eighty acres more or less, except Approximately five (5) acres of land located and/lyng in the extreme northeast corner of the northeast quarter (NE1) of the northeast quarter (NE1) of section 18, township 17 north, range 13 east, in Tulsa Courty, Oklahoma, more particularly described as follows, to-wit:
