This indenture, made and entered into as of the fifteenth day of October, 1924, by and between TULSA MASONIC BUILDING ASSOCIATION, OF TULSA, OKLAHOMA, a corporation, organized and existing under the laws of the state of Oklahoma, with its principal office in the City of Tulsa, in said State, party of the first part, sometimes hereinafter called first party; and EXCHANGE TRUST COMPANY, OF TULSA, OKLAHOMA, and AMERICAN NATIONAL COMPANY, OF OKLAHOMA CITY, OKLAHOMA, corporations organized and existing under, and by virtue of the Laws of the State of Oklahoma, with principal offices in the City of Tulsa and Oklahoma City, respectively, in said State, parties of the second part, sometimes hereinafter called the Trustees.

WITNESSETH, WHEREAS, the party of the first part has full power and authority to contract debts, to borrow money, to issue and dispose of its obligations, and to convey and pledge, by way of mortgage or deed of trust, all of its property to secure the payment of such obligations, and the interest thereof, and the performance of its undertakings with respect thereto; and
