this conveyance is to be a conveyance of all of their Royalty interest to-wit: Of the 1/6 of oil or gas found under above described property.

Hanson, his successors, and assigns, that at the delivery of these presents that they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance in fee simple of and in and to all the aforesaid premises and the approperty; and that they have a good right to sell and convey the same and warrants the same to be free, clear and discharged and unincumbered of and from all former grants, charged, judgments, taxes, etc.

It is hereby expressly declared and intended to pass to, and vest in him, E. E. Hanson, all of the 1/8 royalty interest now owned by them in all of the oil and gas found or that may be found on the premises above described; and any Pipe line company or Oil companys are hereby instructed to pay the 1/8 royalty interest of all such oil and gas directly to the said E.
