NOW, in pursuance of said agreement and consideration of One Dollar (\$1.00), cash, in hand paid, the receipt of which is hereby acknowledged, the first party grants unto the said second party, his successors, heirs and assigns, for and during a period of Ten (10) years, the right to use said pipe-line as a passway, for the purposes has hereinabove described and set forth. It being specifically agreed and understood by and between the parties hereto that the party of the second part is to build, construct, maintain and operate such pipe-line at his own cost and expense; and that the party of the second part, his assigns, servants, agents and licensees and heirs, is at all times to be given the full right and authority to freely pass and repass on the same, to build, construct, maintain, operate and repair the said pipe-line, on and over said lands, provided, however, that the said pipe-line is to be buried to such a depth as will prevent the same from interfering or obstructing in any way the erecting, by the party of the first part, or its assigns, of any tanks, buildings or other improvements on the said land above described.
