268786 C.J. RENTAL CONTRACT

THIS AGREEMENT, made and entered into this 29 day of Sept. 1924 by and between Ed Abraham of Bristow, Oklahoma, party of the first part Geo H. Ennis, of Mounds, Oklahoma, party of the second part;

WITNESSETH, That in consideration of the covenants and agreements hereinafter made, the party of the first part has let, leased and demised, and does by these presents, let, lease and demise unto the party of the second part, his heirs or assigns, for agricultural purposes, from the 1st day of January, 1925, to the 31st day of December, 1927, (Three years) the following described land situated in Tulsa, County, State of Oklahoma, to-wit:

E $\frac{1}{2}$  of NE $\frac{1}{4}$  & NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Sec. 9 Tp 16 N. R., 13 E containing 120 acres, more or less.

The said party of the second part, for the use of said land, agrees to pay the party of the first part as rent (\$-----) DOLLARS per annum, during the term of this contract, payable as follows:

\$200.00 cash in hand for which a receipt is hereby acknowledged in full settlement of this contract.

"This lease covers 120 acres less approx. 10 acres which is subleased to the Sinclair Pipe Line Oil Co., for the full term of this contract.

The party of the first part agrees, that during the term of this contract, to put, keep and protect second part his heirs or assigns, in quiet and peaceable possession of the above described land during the term of this contract.

Said first party agrees to give peacefully possession of said land on the 1st day of January 1925.
