AGRICULTURAL LEASE.

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Walter Anderson is the owner of the East Half (E $\frac{1}{2}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ), and the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Thirty-three (33), Township Nineteen (19) North, Range Eleven (11) East, in Tulsa County, Oklahoma, containing 120 acres more or less, and

WHEREAS, on the 28th day of September, 1923, for a good and valuable consideration, he executed in writing a five year agricultural and grazing lease covering said land, to H. E. Bridges, of Tulsa County, Oklahoma, and

WHEREAS, on the ----- day of October, 1924, H. E. Bridges assigned and transferred all of his right, title and interest under said lease from Walter Anderson, to Conn Linn, of Tulsa, Oklahoma.

NOW THEREFORE, in order to ratify and confirm said lease to H. E. Bridges and the Transfer thereof to Conn Linn, and in order to extend the period of said lease one year so that the same may run for five years from and after this date, I, the undersigned, Walter Anderson, owner of the above described 120 acres of land do hereby let, lease and rent the same land to Conn Linn, of Tulsa, Oklahoma, for a period of five years from this date, for agricultural, grazing and general farm purposes only, consideration for which has this day been paid to me by said Linn in full, the receipt whereof is hereby acknowledged. The said Conn Linn hereby agrees that upon the expiration of this lease to re-deliver said property to me in as good condition as received, natural wear and tear excepted.

It is further agreed by and between the parties hereto that the terms and conditions of this lease shall extend to and be binding upon the heirs, assigns, executors and administrators of the parties hereto, and that the lessee shall have the right to assign the same.
