RIGHT OF WAY DEED
To the Missouri, Kansas & Oklahoma Railroad Company.

KNOW ALL MEN BY THESE PRESENTS:

That I, Eliza Fields as Mother and Natural guardian of Tom Fields a minor and incompetent because of tender years, of the Creek Nation, Indian Territory, party of the first part, for and in consideration of the sum of One Hundred Forty Six 36/00 (\$146.36) Dollars paid to me, the receipt whereof I do hereby acknowledge, do hereby give, grant, bargain, sell and convey unto the MISSOURI, KANSAS AND OKLAHOMA RAILROAD COMPANY, a corporation created and existing under and by virtue of the laws of the Territory of Oklahoma, party of the second part, its successors and assigns, the following tract or parcel of land, real property and premises, situated in the Creek Nation, Western Judicial District of the Indian Territory, that is to say:

A strip, belt or piece of land One Hundred (100) feet in width, comprising all that portion of The Southwest quarter (SW $\frac{1}{4}$) of Section Number Twenty three (23) in Township number Nineteen (19), North of Range Number Thirteen (13) East, Extending from the East line of said 160 acre tract at Station No. 2106&91 Northwestery a distance of 3468 feet to the North line of said quarter section at Station No. 2141 & 59, of the Center line of said railroad the same being fifty feet on each side of the center line of said Company's railroad as the same is now located and surveyed over and across the above described subdivision of land, the map of which said survey of said railroad has heretofore been approved by the Secretary of the Interior⁷ and to other strips of land, each being 25 feet in width, one lying Northerly of and the other lying Southerly from, adjacent to and parallel with the above described 100 feet of right of way, both of said strips extending from the East line of said 160 acre tract, a distance of 309 feet to Station No. 2110 of said center line. Also, two more strips of land each being twenty five (25) feet in width, one lying North Easterly of , and the other lying Southwesterly from, adjacent to and parallel with the first above described 100 feet of right of way, both of said strips beginning 1109 feet NWly from the East line of said 160 acres tract at station No. 2118 and extending 1700 feet Northwestery to Station No. 2135 of said center line of said Railroad,

TO HAVE AND TO HOLD the premises hereby conveyed, with all the rights, privileges and appurtenances thereunto belonging or in anywise appertaining, unto the said MISSOURI, KANSAS and OKLAHOMA RAILROAD COMPANY, party of the second part, its successors and assigns, in fee simple forever, free, clear and discharged of and from all former grants, charges, taxes, judgments, mortgages and other liens and incumbrances of whatsoever nature; and I, the said Eliza Fields as such mother and Natural guardian of said Tom Fields, a minor and incompetent because of tender years, and for and on behalf of said Tom Fields and his heirs, executors and administrators, hereby covenant to warrant and defend the title to the premises hereby conveyed against the claims of any persons or party.

This deed is made by the party of the first part over the allotment of the said Tom Fields , the Certificate Number which is Number 1519, under authority of the provisions of the Act of Congress of March 2, 1899, and is intended to convey all such right as said party of the first part may lawfully convey to said party of the second part under the provisions
