The reason for releasing the original mortgage is that it imperfectly described the debt and was not acknowledged by the mortgagors. Upon discovery of this error a new mortgage correctly describing the debt and property and acknowledged was taken dated as of August 14, 1924, to take the place of the original imperfect mortgage.

Beginning at a point 2640 Feet South and 2120 East of the NW corner of said Section. Thence bearing North 49° and 30' Min West a distance of 2510 feet to a point 810 feet South of the NW corner of said Section 11 Twp 17 North range 12 East.
