RELEASE OF OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENTS: That

WHEREAS, on the 17th day of February, 1912, G. T. Braden made, executed and delivered to the United Fuel Supply Company, a corporation, a certain oil and gas lease covering the North Half (N/2) of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section Sixteen (16), Township Nineteen (19) North, Range Thirteen (13) East, situate in Tulsa County, Oklahoma,

which lease is recorded in Book 116, page 175, of the records of said county; and

WHEREAS, on the 1st day of October, 1915, said lease and all rights thereunder were assigned by the said United Fuel Supply Company, a corporation, to Caney River Gas Company, a corporation, which assignment is recorded in Book 189, page 434, of the records of said county; and

WHEREAS, subsequent to the date of said assignment all of the assets, real, personal and mixed, including said lease, belonging to Caney River Gas Company, a corporation, were acquired and taken over by the Oklahoma Natural Gas Company, a corporation, and the said Caney River Gas Company thereupon was dissolved; and
