FOURTEENTH:- (a) This trust shall continue from the date hereof for a term of twenty (20) years after the desth of the last surviving person named herein, at the termination of which period of the then Board of Trastees shall proceed to wind up its affair liquidate its assets, and distribute the same among the holders of the shares according to the value and priorities therein express: PROVIDED, HOWEVER, that if prior to the expiration of said corried the holders of at least a majority of the shares then outstanding, shall consent to or ratify a proposal of the trustees to terminate or continue this trust, then sold trust shall either terminate or continue in existance for a further like period of for such shorter period as may been be determined.
