OKLAHOMA FIRST MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS: That Charles A. Baird and wife, Cora M. Baird of Tulsa County, State of Oklahoma, parties of the first part, have mortgaged and hereby mortgage to Annie Coe Kerr party of the second part, the following described real estate and premises, situated in Tulsa County State of Oklahoma, to-wit:

Lot Twenty (20), Block Sixteen (16), Lynch-Forsythe Addition to the City of Tulsa, with all the improvements thereon and appurtenances therunto belonging, and warrant the title to the same.

This mortgage is given to secure the principal sum of SIXTEEN HUNDRED Dollars, due and payable on the 30th day of October, 1927, with interest thereon at the rate of 8 per cent, per annum, payable semi-annually from date, according to the terms and at the time and in the manner provided by One certain promissory note of even date herewith, given and signed by the makers hereof and payable to the order of the mortgagee herein, and being for the principal sum of SIXTEEN HUNDRED dollars, with Six coupon notes attached, evidencing said interest, one coupon being for Sixty-four Dollars, and Five coupons being for Sixty-four Dollars each.

IT IS EXPRESSLY AGREED AND UNDERSTOOD by and between the said parties hereto that this Mortgage is a first lien upon said premises; that the party of the first part will pay said principal and interest at the times when the same fall due and at the place and in the manner provided in said note, and will pay all taxes and assessments, against said land when the same are due each year, and will not commit or permit any waste upon said premises; that the buildings and other improvements thereon shall be kept in good repair and shall not be destroyed or removed without the consent of the second party, and shall be kept insured for the benefit of the second party or its assigns, against loss by fire and storm for not less than Twenty-five Hundred DOLLARS, in form and companies satisfactory to said second party or his representative, and that all policies and renewals of same shall be delivered to said second party or his representative.
