FIRST. The mortgagors represent that they have fee simple title to said land, free and clear of all liens and encumbrances, except first mortgage as appears of record; and hereby warrant the title against all persons, waiving hereby all rights of home stead exemption, and waive the appraisement of said lands in case of sale under foreclosure.

SECOMD: If sadd mortgagors shall pay the aforesaid indebtedness both principal and interest, according to the tenor of said notes as the same shall mature, and shall keep and perform all the covenants and agreements in this mortgage, then these presents shall become void; Otherwise to remain in full force and effect.

THIRD. Said mortgagors agree to pay promptly when due and payable all taxes and assessments that may be levied within the State of Oklahoma, upon said lands and tene-ments, or upon any interest or estate therein including the interest represented by this mortgage lien; and further to pay any tax, assessment or charge that may be levied, assessed against or required from the holder of said mortgage and notes as a condition to maintain or of enforcing or enjoying the full benefit of the lien of this mortgage, or the collection of said indebtedness; and will pay any and all labor and material liens whether created before or after this date that are lawfully charged against said premises;

and will also keep all buildings erected and to brected upon said lands, insured, against loss and damage by tornado and fire with insurance approved by the mortgagee herein in the sum of \$525.00 as a further security for said debt, and assign and deliver to the mortgagee all insurance upon said property to be by it collected, as its interest may appear. Incase said mortgagors shall fail to pay any such taxes, assessments, charges, labor or material liens or insurance, then the holder of this mortgage and the debt secured hereby may pay said taxes, assessments, insurance, charges and liens, and said mortgagors agree to repay upon demand the full amount of said advances with interest thereon at the rate of ten per cent per annum from the date of such advancement and this mortgage shall be further lien for the repayment thereof.

FOURTH . Mortgagors agree to pay promptly when due all interest or principal payments on all prior encumbrances if any upon said land, and if mortgagors or their successors in the ownership of the land here in mortgaged default in payment of either principal or interest of any prior encumbrance, the holder of the notes secured by this mortgege may pay off such prior encumbrance in full, or the amount due thereon whether principal or interest, or may pay off the entire prior encombrance in full, and mortgagors agree forthwith to repay same with interest at the rate of ten per cent (10%) per annum from date of such advancement and the lien of this mortgage shall extend to and prefect such advances and interest and if the same be not paid within thirty (30) days from date of advancement, the holder of the notes secured hereby may at any time thereafter proceed to forsclose this mortgage and all the indebtedness secured by said notes shall become at once due and payable at the option of the holder thereof. Non-compliance with any of the agreements made herein by the mortgagors shall cause the whole debt secured hereby to mature at the option of the holder hereof, and no demand for the fullfillment of broken obligation or conditions, and no notice of election to consider the debt due shall be necessary before instituting suit to collect the same and foreclose this mortgage, the institution of such suit being all the notice required.

Grantors agree that in case default occurs upon this mortgage indebtedness or any part thereof, and suit is instituted to collect the sume of as per noted as a reasonable attorney a fee in addition to all other legal coats, as often as any legal procoodings are taken to foreclose this mortgage for default in any of its covenants, or as often as the said mortgagors or mortgages may be made defendant in any suit affecting the title to said property which sum shall be and additional lien on said premeas, and shall become due con the filing of petition or cross petition or forcolosure.
