Hereby a trust is created under the terms of Chapter Sixteen Session Laws on 1919 of the State of Oklahoma entitled.

"An Act supplemental to the amendatory of Article

IV, Chapter 65, Revised Laws of Oklahoma, 1910, etc".

Said trust estate shall be known as BARTLETT DEVELOPMENT SYNDICATE NO. 1, and its principal business shall be conducted at its offices in room 229, Clayton Building Sapulpa, Oklahoma, or such other place or places as said Trustees shall by resolution determine, for the term of the life of H. U. Bartlett and Twenty years thereafter unless sooner wound up hereunder.

Said trustees, or the majority of the trustees jointly if any other one or more are added hereunder, shall have power to conduct a business in said name anywhere in the State of Oklahoma, in operating any well or wells producing oil or gas or either; or to locate, drill, develop, explore for producing wells of oil or gas or either of them; of carrying or transporting crude oil or petroleum or natural gas, or any of the products of either or both by and through pipe line, tank car, trucks or wagons, for hire or otherwise; of refining or manufacturing any of the product of either petroleum or natural gas, either for hire or otherwise; of storing or engaging in the business of buying or selling or dealing in petroleum, natural gas, or the products of either, and shall have
