## RIGHT OF WAY AGREEMENT

THIS AGREEMENT made and entered into on this 11th day of November, 1924, by and between E. R. Minshall and J. M. Givens hereinafter called the Grantor, and Oklahoma Natural Gas Company hereinafter called the Grantee.
