## FIRST MORTGAGE REAL ESTATE NOTE

FOR VALUE RECEIVED, I, we or either of us, jointly and severally, promise to pay to INDUSTRIAL BUILDING & LOAN ASSOCIATION of Tulsa, Oklahoma, on or before ten years after date hereof the sum of Five Hundred & No/100 DOLLARS, with interest from date, in monthly installments of Four & 17/100 - - -Dollars; also monthly dues on 40 shares of Class-installment stock of said association in the sum of Twenty & No/100 - - -dollars, both interest and dues being payable on the 5th day of each and every month until sufficient assets accumulate to mature said shares and pay the holder thereof one hundred dollars for each share according to the terms of the by-laws of the Association, and in case of default in the payment of interest, or dues, or any part thereof, at the stated times, or failure to comply with any of the conditions or agreements stated in the mortgage securing such payments, then this note shall immediately become due and payable at the option of the legal holder hereof, and shall after such default bear ten per cent interest per annum and if collected by suit, we agree to pay an additional ten per cent of the amount due as attorney's fees.
