receive the rents, profits and incomes thereof, and have full control of the same, so long as said default exists, or may apply to any Judge or Court having jurisdiction to appoint, and have appointed, a receiver to take charge of said property and preserve the same and collet the rents and profits thereof, and may proceed to foreclose said mortgage and have said property sold, and the proceeds thereof, together with the rents and profits applied first, in payment of the costs of suit and sale, and Two hundred thirty and No/100 Dollars \$230.00 attorney's fee, which the court shall tax for plaintiff in the action, and all moneys which may have been advanced by party of the second part for insurance, taxes and other charges, liens and assessments, with interest thereon from date of advancement at ten (10) per cent, per annum, all of which shall become a lien on said premises; second, to pay all sums of money due and payable upon the first mortgage bond secured hereby, with the accrued interest and fines thereon, and, third, the overplus, if any, to be paid to the party of the first part their legal representatives or assigns.
