That on the 24th. day of December, 1924, Thompson & Black, Inc., executed a release on the NW $\frac{1}{4}$ NE $\frac{1}{4}$ Sec. 10, T 16 N. R. 12 E., which said release is recorded in Book 489, Page 526 of the records of the County Clerk of Tulsa County, and that well known as the Glass #1 and located in the NW corner of said forty acres was drilled by M L Glass thereby in no way extending the life of that portion of the lease held jointly by Thompson & Black, Inc., John T.
