until sixty (60) monthly payments have fallen due and been paid, the sum of Sixteen and 65/106 (\$16.65) Pollars (which is made up of the sum of Inirteen and 33/100 (\$13.33) Pollars as installments of interest upon said loan), and to secure all other covenants and conditions in said note and contract set forth, reference to the game being hereby expressly made.

It is expressly agreed and understood by and between the said parties hereto that this mortgage is a first lien upon said premises, that the said part of the first part will pay the said installments of principal and interest when the same fall due and at the place and in the manner provided in said note and contract, and will pay all taxes and assessments against said land and premises when the same aredue each year, and will not commit or permit any waste upon said premises; that the buildings and other improvements thereon shall be kept in good repair and shall not be destroyed or removed without consent of said second party, and shall be kept insured for the benefit of said second party, or assigns, against loss by fire or storms in the sums respectively set out in said note and contract, in form and companies satisfactory to second party, with loss under said palicies payable to the said second party, and that all policies and renewals of same shall be delivered to said second party. It is further agreed that upon a breach of the warrant herein or in the event of default in payment of installments of principal and interest for the speace of three months, or non-payment of insurance premiums, taxes, assessments, or other charges, or failure to insure the premises or to pay any premium for any such insurance which may have been advanced by said second party, or failure to keep the said improvements in good repair and in a tenantable condition, or in the event any act of weste is committed on said premises.
