and not en association or partnership, and no portion of this agreement shall be construed or interpreted as being contrary to this provision. All property of the company is the legal property of the trustees and they are the masters. The shareholders shall be trust beneficiaries only, without partnership, associate or other relation whatever intersese.

SECTORD:-The turstees in their collective capacity, and their successors in the trusteeship, shall be signated so far as practicable as "ISEELL PHARMACAL COMPANY", and under that name, shall so far as practicable, conduct all business, receive and convey title to "real, personal or mixed property and shall by and through their authorized officers execute any and all deeds, conveyances, leases, contracts, assignments and other instruments in writing, in performance of their trust; and said name and the woods "Company", "T⁴uet" and "Trustees" whenever used in this instrument shall be interchangeable.

THIRD:-(a) The trustees shall always be three in number and the trustees herein mentioned shall hold the trustee-ship for the life or duration of the trust, or until their successors have been duly elected and have accepted this trust.

(b) In event of the death, resignation, inability or refusal to act of any of the trustees, the remaining trustees shall fill any vacancy for the unexpired portion of the currant fiscal year at the termination of which they shall refer and submit to the shar holders for their individual approval the names of such proposed permanent trustees as they may have named to fill such vacancies and upon the holders in interest of a majority of the shares then outstanding consenting to, ratifying or approving said appointments so made by the trustees, the said appointments shall become permanent for the unexpired term of the original trustees named herein, subject to all the terms and provisions hereof. As soon as any trustees or trustees elected by the remaining trustees, or by the shareholders to fill a vacency shallhave accepted this trust, the trust estate shall immediately vest in the new trustee or trustees, together with the remaining trustees without any further act or conveyance.

FOURTH: -! (a) The trustees shall hold the legal title to all property at any time belonging to the trust, and shall have and exercise the exclusive management and control of the same; they shall, as trustees, ascume all contracts for and obligations and liabilities in connection with or growing out of the property, rights, securities or things of value assigned to them by the Trustor, or others, and the management of the same as before specified, to the extent of the value of such rights, property, and business, BUT NOT ENTSCRALLY; they shall conduct the fifairs of the trust in such amanner as to save the holders of beneficial interests herounder harmless and indemnified from and against any loss, cost, expense or liability, by reason of, or in connection with any such contract, obligation or liability; they may adopt and use a trustees' seal; they may collect, sue for, receive and receipt for all moneys at any time coming due to said trust; they may employ counsel to begin, prosecute, defend and settle suits at law, equity or otherwise; with the consent of all their memberes, but not otherwise, they may borrow money for purposes incidenta to the proper management and conduct of said trust, and may issue wonds, indentures, certificates or other written evidences of indebtedness to secure the repayment of such loans; they may buy, sell, exchange, mortge or convey real estate, personal property, leases, royalties, or equities therein wherever located; they may manufacture, buy, sell or trace generally in goods, wares, merchandise and personal property of any and every class. and description and wherever situated.

(b) They may especially engage in the business of genuicoturing, marketing, buying, acquiring, selling and dealing generally in medical goods, medicines, phormaceuticals areas, medical appliances, durgings sundreis, and specialties of every kind and character; 99
