This Indenture, Made this 21 day of Sept A. D., 1906 between George W. Adams and Minnie E. Adams his wife of Tulsa Indian Territory, Western District, party of the first part, and The Southern Building Company of Tulsa, Indian Territory, a corporation, party of the second part, witnesseth, that the said party of the first part, for and in consideration of the sum of One dollars,

in hand paid by the said party of the second part (the receipt whereof is hereby acknowledged), has remised, released, sold, conveyed and quit-claimed, and by these presents does remise, release, sell, convey and quitclaim unto the said party of the second part, his heirs and assigns, forever, all the right, title, interest, claim and demand which said party of the first part has in and to the following described lot piece or parcel of land or improvements, situated in the Leuk Nation Indian Territory, Western District, and known and described as follows, to wit:

Lot Eight (8) in Block Six (6) in the Kind and Gillette's Addition to the City of Tulsa, Being a part and parcel of the South-west quarter (SW 1/4) of the North-east quarter (NE 1/4) of the North-west quarter (NW 1/4) of Section Twelve (12) Township Nineteen (19) North of Range Twelve (12) East of the Indian Meridian.

To have and to hold the same, together with all and singular the appurtenances and privileges thereunto belonging or appertaining, and all the estate, right, title, interest and claim whatever of the said party of the first part either in law or equity to the only proper use, benefit and behoof of the said party of the second part, unto his heirs and assigns, forever.

And I, Minnie E. Adams wife of the said George W. Adams for and in consideration of the said sum of money, do hereby release and relinquish unto the said The Southern Building Company all my rights of dower and homestead in and to the said lands.
