

QUIT CLAIM DEED.

WITH RELINQUISHMENT OF DOWER.

This Indenture, Made this 2nd day of April A. D. 1907 between George W. Adams and Minnie E. Adams his wife of Tulsa Indian Territory, Western District, party of the first part, and James E. Dunn of St Louis Mo, party of the second part, witnesseseth, that the said party of the first part, for and in consideration of the sum of One dollar, in hand paid by the said party of the second part (the receipt whereof is hereby acknowledged), has remised, released, sold, conveyed and quit-claimed, and by these presents does remise, release, sell, convey and quitclaim unto the said party of the second part, h. u. heirs and assigns, forever, all the right, title, interest, claim and demand which said party of the first part has in and to the following described lot piece or parcel of land or improvements, situated in the Creek Nation Indian Territory, Western District, and known and described as follows, to-wit:

An undivided one third (1/3) interest in Lot no
One (1) in Section eleven (11) township number
(19), Range Twelve (12) east

To have and to hold the same, together with all and singular the appurtenances and privileges thereunto belonging or appertaining, and all the estate, right, title, interest and claim whatever of the said party of the first part either in law or equity to the only proper use, benefit and behoof of the said party of the second part, h. u. heirs and assigns, forever.

And I, Minnie E. Adams wife of the said George W. Adams for and in consideration of the said sum of money, do hereby release and relinquish unto the said James E. Dunn all my rights of dower and homestead in and to the said lands.
