## KNOW ALL MEN BY THESE PRESENTS:

That L. Van Vliet  
for and in consideration of ONE DOLLAR to him in hand paid, and the premises hereinafter set forth do hereby grant, bargain sell and convey unto  
G. L. Elmore of Broken Arrow  
Indian Territory, and unto his heirs and assigns, for ever, the following property situated in the Lots one two three four five six and seven in Block fifteen (15) North Addition to Broken Arrow, I. T.

To have and to hold the same to the said G. L. Elmore  
his heirs or assigns, together with all and singular the appurtenances and improvements thereunto belonging; and  
I hereby covenant with the said G. L. Elmore that I will forever warrant and defend the title to  
said property against all lawful claims.

And I Louisa Van Vliet wife of the said L. Van Vliet  
do hereby release all my right and dower in and to said lands. This sale is on condition that:

Whereas, the said L. Van Vliet  
justly indebted to the said G. L. Elmore in the sum of  
one hundred and DOLLARS,  
evidenced by promissory note of even date herewith by which promise to pay to the order of  
Payable to the order of G. L. Elmore the sum of for one hundred Dollars (\$ 100.00)  
for value received any months days after date executed by L. Van Vliet and Louisa Van Vliet  
with interest at eight per cent per annum after from date

First parties agree to keep the buildings on the above premises constantly insured against loss by fire and tornado in a sum not less than \$ 2500  
and loss, if any, payable to second party, as interest may appear at the time, and policies delivered to said second party, and to keep all taxes paid.

Now, if said first parties, or anyone for them shall pay said moneys at the time and in the manner aforesaid, then the above conveyance shall be null and void. And  
in case of non-payment of same or any part thereof, or a failure to keep said insurance and tax agreements, then the whole shall be at once due and payable and the said  
grantee or his assignee, agent or attorney in fact, shall have power to sell said property at public sale, to the highest bidder for cash at the front door of the Court house in  
the city of Broken Arrow Indian Territory, public notice of the time and place of said sale having been first given thirty days, by advertising in  
some newspaper published in said city or by one printed or written hand bills posted in two public places in said city as provided by Sections 3049 and 3356 Mansfield's  
Digest of Laws of Arkansas at which sale the said grantee or his assignee, agent or attorney in fact, may bid and purchase as any third person might do.

And he hereby authorize the said grantee or his assigns to convey said property to anyone purchasing at said sale; and the recitals of this deed of  
conveyance shall be taken as prima facie true. And the proceeds of said sale shall be applied, first to all costs and expenses attending said sale; second, to the payment  
of said debt and interest, and the remainder, if any, shall be paid to said grantor. The homestead appraisalment and right of redemption allowed by law are hereby  
expressly waived
