FIFTH. The said party of the first part agrees to procure and maintain policies of insurance on the said above described premises, in such insurance company

SIXTH. EIGHTH. It is further stipulated and agreed by the first party that upon the institution of proceedings to foreclose this mortgage, the plaintiff therein shall be entitled to have a receiver appointed by the Court to take possession and control of the premises described herein, and to collect the rents and profits thereof, under the direction of the Court, without the proof required by statute; the amount so collected by such receiver to be applied, under the directions of the Court, to the payment of any judgment rendered or amount found due upon the foreclose of this mortgage. The foregoing covenants and conditions being kept and performed this conveyance to be void; otherwise of full force and virtue.
