terms of the lease or the regulations heretofore or hereafter prescribed have been violated in any particular, and further agreed not to transfer, assign, or sub-let, by working or drilling contract or otherwise. or allow the use of the land leased, or any oil or gas in or under it, without first obtaining the consent of the Secretary of the Interior, and that any violation of the lease or of the regulations heretofore or hereafter prescribed by the Secretary of the Interior, respecting oil

If, at any time, the Secretary of the Interior, after due notice to the persons or parties interested, determines that any person, partnership, or corporation has, by means of stock ownership or otherwise directly or indirectly, obtained and holds interests in leases of oil and gas properties in said Territory, said leases covering, in the aggregate, an area of more than 4800 acres, and further finds that the property herein leased is a part of said aggregate area, then the Secretary of the	
Interior may cancel this Lease in the same manner as provided for in the case of any violation of the terms of said lease.  It is further agreed and understood that the approval of this Lease shall be of no force or effect, unless the part
