SINTH. For value received, the party of the first part hereby waives all benefits of the stay, valuation or appraisement laws of the State of Oklahoma; and further agrees that the contract embodied in this mortgage and note secured hereby shall in all respects be governed, construed and adjudged according to the laws of the State of Oklahoma at the date of their execution.

EIGHTM. It is further stipulated and agreed by the first party that upon the institution of proceedings to foreclose this mortgage, the plaintiff therein shall be entitled to have a receiver appointed by the Court to take possession and control of the premises described herein, and to collect the rents and profits thereof, under the direction of the Court, without the proof required by statute; the amount so collected by such receiver to be applied, under the directions of the Court, to the payment of any judgment rendered or amount found due upon the foreclose of this mortgage. The foregoing covenants and conditions being kept and performed this conveyance to be void; otherwise of full force and virtue.

NINTH. In construing this mortgage the words "first party," wherever used, shall be held to mean the persons named in the preamble as parties of the first part, jointly and severally.

It is expressly stipulated that, upon default herein, suit to foreclose this mortgage may be brought in any County where the real estate mortgaged is situated, egardless of residence of mortgagors, or either of them, and all objections to venue of such suit are hereby expressly waived.
