WITNESSETH: That the party of the first part for and in consideration of the sum of One & no/100 Dollars, cash bonus, and the royalties, covenants, stipulations and conditions herein-after contained, and hereby agreed to be paid, observed and performed by the party of the second part, its heirs, successors and assigns, do hereby demise, grant and let unto the party of the second part, its heirs, successors and assigns, for the term of 10 years from the date hereof, not, however, beyond, the majority of said minor, all the oil deposits and natural gas in or under the following described tract of land, lying and being within the county of Creek State of Oklahoma, to wit:

Beginning at the Northwest Corner of Section 27, Township 17, Range 12 East; thence south 69 yds. 20 in.; thence East 69 yds. 20 in.; thence North 69 yds. 20 in.; thence West to place of beginning. containing one acre more or less, with the right to prospect for, extract, pipe, store, refine and remove such oil and natural gas and to occupy and use so much only of the surface of said land as may be reasonably necessary to carry on the work of prospecting for,
