DEED OF ASSIGNMENT OF LEASE.

THIS INDENTURE, Made this twentieth day of February, 1909, between John D. Porter, of Tulsa, Oklahoma, party of the first part, and the Okla-Tulsa Oil and Gas Company, a corporation, duly incorporated under the laws of the state of Missouri, party of the second part,

WITNESSETH: That for and in consideration of the sum of One Dollar, in hand paid by said party of the second part receipt of which is hereby acknowledged and other good and valuable considerations, the said John D. Porter does hereby sell, assign and set over to the said Okla-Tulsa Oil and Gas Company, all of ^{his} ~~its~~ rights, title and interest in and to a certain oil and gas mining lease on the following described real estate, lying and being in Tulsa County, State of Oklahoma, to-wit:

The North East Quarter of the South East Quarter of Section Twelve (12), Township Nineteen (19) North, Range Fourteen (14) East, containing Forty (40) acres, more or less, which said lease is dated, the 10th, day of September, 1908, and executed by Knox M. Rowe, of Broken Arrow, Oklahoma, to the said John D. Porter and filed for record in the office of the Register of Deeds for Tulsa County, Oklahoma, on November 25th, 1908, and is recorded in record thirty six (36) page Four Hundred Fifty six (456)

Also the South East Quarter of the South East Quarter of Section Twelve (12), Township Nineteen (19) North, Range Fourteen (14) East, containing Forty (40) acres, more or less, which said lease is dated, the 5th, day of December, 1908 and executed by Knox M. Rowe, of Broken Arrow, Oklahoma, to said John D. Porter and filed for record in the office of the Register of Deeds of Tulsa County, Oklahoma, on February 8th, 1908 and is recorded in record thirty six at page five hundred thirty two (502)

Also the East Half of the South West Quarter and the South West Quarter of the South West Quarter of Section Twelve (12) Township Nineteen (19) North, Range Fourteen (14) East, containing One Hundred and twenty acres, more or less, which said lease is dated the 10th, day of September, 1908 and executed by Guy Bowman, of Muskogee, Oklahoma, to the said John D. Porter and was filed for record in the office of the register of Deeds of Tulsa County, Oklahoma, on November 25th, 1908 and is recorded in record thirty-eight, at page six hundred thirty eight.

Also the North West Quarter of the South West Quarter of Section Twelve (12), Township Nineteen (19) North, Range Fourteen (14) East, containing Forty (40) acres more or less, which said lease is dated the 12th, day of September 1908, and executed by John D. Coffman, of Broken Arrow, Oklahoma, to the said John D. Porter and filed for record in the office of the Register of Deeds for Tulsa County, Oklahoma, on November 25th, 1908 and is recorded in record thirty six at page four hundred fifty five (455).

TO HAVE AND TO HOLD with all the rights, privileges and immunities thereto belonging and granted in said lease aforesaid, and subjecto to the restrictions therein, to operate and enjoy all benefits thereto accruing.
