OIL AND GAS LEASE.

THIS AGREEMENT, made and entered into, in triplicate, on this 31 day of December, A. D., 1908, by and between Thomas Grayson, as Guardian of the Estate of Jesse Adams, a minor, of Beggs, Oklahoma? party of the first part, and G. T. Braden, of Pittsburgh, Pa., party of the second part:

WITNESSETH: That the party of the first part, for and in consideration of the sum of Six Hundred Forty Dollars (\$640.00) cash bonus, in hand paid, the receipt whereof is hereby acknowledged, and the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid, observed and performed, by theparty of the second part, his heirs, successors and assigns, does hereby demise, grant and let unto the party of the second part, his heirs, successors and assigns, for a term ending July 8th, 1926( not however, beyond the majority of the said minor) all of the oil deposits and ratural gas in and under the following described tract of land, and also said tract of land for the purpose and with the exclusive right of operating thereon for oil and gas; together with the right of way over said premises, the exclusive right to lay pipe over and upon the same, to erect and maintain thereon all machinery, buildings, powers, tanks, fixtures, and telephone and telegraph lines necessary or required in operating for oil and gas; which tradt of land is situated within
