AGREEMENT.

THIS AGREEMENT, Made and entered into this 6th, day of February, 1909, by and between Page Investment Company, a corporation duly organized and existing under the laws of Oklahoma, and the Ellington Oil Company, a corporation duly organized and existing under the laws of Arizons which said corporations are hereinafter designated the first parties, and the Producers Oil Company, a corporation duly organized and esisting under the laws of the State of Jexas, and hereinafter designated the second party.

WITNESSETH: The said first parties, subject to the approval of the Sedretary of the Interior and for and in consideration of the approval of the Secretary of the interior and forand in consideration of the sum of Fifteen Thousand Dollars čash in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, and of other valuable considerations hereinafter set forth, hereby grant, bargain, sell, assign and transfer unto the said second party, its successors and assigns, a certain oil and gas mining lease heretofore entered into, on the 1st day of December, 1905, by and between Cheparn Holahta and Lucy Holahta, his wife, as heirs at law of Martha Holahta, deceased, and the said Page Investment Company, and covering the following lands situate in Tulsa County, State of Oklahoma, to-wit:

The West Half of the Southeast Quarter and the South East Quarter of the South West Quare ter of Section Thirty Four (34), in Township Eighteen (18) North, Range Twalve (12) East, containing120 acres, which said lease was duly approved on November 21, 1906, by Thomas Ryan, First Assistant Secretary of the Interior, together with all the property of every kind which the said Page Investment Company has in, under and upon said lands, including all gas, all oil, whether produced or not, all rigs, tanks and the contents thereof, pipes, pipe lines, casings, tools and machinery, applinces and fixtures; but the said secondparty hereby agrees to pay Six Hundred and Fifty Five (\$655.00) Bollars which is due and owing for the erection of what is known as Rig No. 4 on said lands; and, for the consideration above stated and hereinbelow stated, the said first parties, subject to the approval of of the Secretary of the Interior, hereby grant, bargain, sell, assign, and transfer to the said second party, its successors and assigns, a certain oil and gas mining lease heretofore entered into, on the 22nd, day of December, 1906, between Belcher Ispocogee, as Guardian of Sam Ispogogee, a minor and the said Ellington Oil Company, and covering the East Half of the South West Quarter of the Southwest Quarter of Section Thirty Four (34), Township Eighteen (18) North, Range Twelve (12) East, containing 20 acres, which said lease was, on the 19th, day of February, 1908 duly approved by Jesse E. Wilson, Secretary of the Interior, together with all the rights, privileges, franchises and appurtenances thereunto belonging.

TO HAVE AND TO HOLD the said above mentioned personal property unto the said secondparty its successors and assigns, absolutely and forever, and said leases upon said lands for and during the term specified in said leases; and the said first parties hereby covenant and agree
