OIL AND GAS LEASE.

THIS AGREEMENT, Made and entered into, this 23rd, day of January, A. D., 1909, by and between Milton Thompson as guardian of Francis L. Thompson, a minor, 1/16 blood, party of the first part, and the Lucas Oil Company Party of the second part:

WITNESSETH:- That the said party of the first part for and in consideration of the sum of One (\$1.00) Dollar, and other valuable consideration in hand well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained, on the part of the party of the second part to be paid kept and performed, has granted, demised, leased and let, and by these presents do grant, demise, lease and let unto the said party of the second part, its, heirs, successors and assigns for the sole and only purpose of mining and operating for oil and gas and of laying pipe lines, constructing tanks, buildings and other structures thereon to take care of said products, all that certain tract of land situated in the County of Tulsa & Rogers, State of Oklahoma, bounded and described as follows, to-wit:

S/2 of SE/4 of SE/4 of Section 21, and NE/4 of NE/4 of Section 28, all in township 20
