## O R D E R.

Now on this 23rd, day of January, 1909, this matter comes on for hearing, for the confirmation of certain oil and gas leases executed by Milton Thompson, as guardian of the persons and estates of Joseph H. Thompson, Mary A. Thompson and Francis L. Thompson, minors, to the Lucas Oil Company, on the allotments of said minors, located in Tulsa and Rogers County, Oklahoma, authorized and empowered pursuant to an order of this Court, dated on the 8th, day of January, 1909.

And it appearing to the Court that the petitioner in this case, Milton Thompson is the farther and legal gaurdian of said minors, that said guardian and said minors are residents of Tulsa County, Oklahoma, and that said minors live with their father, the guardian herein. And it appearing to the court that the allotments of said minors are in what is known as the oil and gas belt and are located more than three miles from an oil and gas well, and the company to whom they have leased agrees to begin drilling operations in the near vicinity of two of said allotments, and immediately on the third of <sup>the</sup> said allotments, within ninety days from the date of said leases. And it appearing to the court that it is to the interest of said minors to lease their lands for oil and gas purposes to the said Company, The Lucas Oil Company.

And it appearing further to the court that notice for bids for leasing said allotments have been properly given in pursuance of <sup>an</sup> said order of this Court, dated the 8th day of January 1909, to-wit: For publication of notice of said leasing in two issues of the Tulsa Democrat, a weekly newspaper published in Tulsa County, Oklahoma: and it appearing to the court that the bid of the Lucas Oil Company for the leases for oil and gas on the lands of said minors hereinafter set out was the highest and best bid made under and by virtue of the order of this Court heretofore made, that the said bid was in writing, and submitted to said guardian on the 23rd day of January, 1909, and accepted by said guardian; and it further appearing to the Court that the order heretofore made in this matter for leasing said lands heretofore described for oil and gas purposes has been fully complied with in every particular, and there being submitted to this court for his approval the oil and gas leases executed upon the allotments hereinafter described by Milton Thompson, as Guardian to the Lucas Oil Company, the highest and best bidder therefor, and the Court being fully advised in the premises and by taking testimony in open court, finds that said leases executed on the 23rd, day of January, 1909, by said Milton Thompson, as guardian of the minors hereinabove named to the Lucas Oil Company upon the allotments as hereinabove described, should be confirmed and approved as follows, to-wit:

Joseph H. Thompson:

SW/4 of SW/4 of Section 21, and N/2 of NW/4 of NW/4 of Section 28, and NE/4 of NW/4 of NW/4 of Section 27, all in Township 20 North, Range 14 East.

Mary A. Thompson:-

NW/4 of SW/4 and W/2 of NE/4 of SW/4 of Section 21, also NW/4 of NE/4 of NW/4 of Section 27, <sup>all in Township 20 North, Range 14 E.</sup>

S/2 of SE/4 of SE/4 of Section 21, and NE/4 of NE/4 of Section 28, and NW/4 of NW/4 of NW/4 of Section 27, all in Township 20 North, Range 14 East.

It is therefore by the Court considered, ordered and adjudged that said leases for oil and gas purposes, executed by Milton Thompson as guardian of the above named minors to the Lucas Oil Company, of date January 23, 1909, upon the property hereinabove described shall be, and the same hereby are, in all their terms, covenants, agreements and conditions ratified, con-
