

ORDER APPROVING DEED.

IN THE MATTER OF THE ALIENATION OF THE ALLOTMENT OF SUNDAY GRAYSON, DECEASED.

O R D E R .

Now, on this the 4th, day of March, 1909, this matter came on for hearing upon the petition of Wattie Grayson, otherwise known as "Watty" Grayson, as an heir at law of Sunday Grayson, deceased, praying for an order of Court approving a certain deed of conveyance by him executed, conveying all his right, title and interest in and to the land described below to R. A. Josey. The petitioner appearing in person and by his attorneys, Abbott and Brown, and the Court after hearing the evidence of the petitioner and other testimony and being fully advised in the premises, finds:

That the allegations in the petition contained a re true; that the petitioner Wattie Grayson, is a full blood Creek Indian, and duly enrolled as such and is of lawful age; that the said Sunday Grayson, deceased, was a full blood Creek Indian, duly enrolled as such, and that there was allotted to him, as his distributive share of the lands of the Creek Nation, the following described land, situate in what is now Tulsa County, Oklahoma, to-wit:

The Northwest Quarter of the Southeast Quarter of Section Four (4), Township Nineteen (19) North, Range Thirteen (13) East, with other lands.

That the said Sunday Grayson, deceased, died on or about the ____ day of May, 1904, while a resident of and in that portion of the Creek Nation of the Indian territory embraced in what is now Tulsa County, Oklahoma; the said Sunday Grayson, deceased, died intestate, and leaving surviving him, as his only heirs at law, this petitioner, Wattie Grayson, Buck Grayson and Dick Grayson, brothers of the said deceased, and Susie Harjo and Jennie Grayson, sisters of said deceased, and that the said Sunday Grayson had no children born to him since the 4th, day of March, 1906;

The Court further finds that on the 4th, day of March, 1909, the said Wattie Grayson made, executed and delivered a deed of conveyance to one R. A. Josey, thereby conveying all his right, title and interest in and to the land above described, in consideration of the sum of One Hundred Twenty Five (\$125.00) Dollars, which consideration the Court finds is adequate and which deed has been exhibited to the Court for approval.

IT IS THEREFORE, by the Court considered, ordered, adjudged and decreed that the said deed, above described be and the same is hereby approved, according to Section 9 of an Act of Congress, approved May 27th, 1908, entitled "An Act for the removal, of restrictions from a part of the lands of the Five Civilized Tribes and for other purposes".
