OIL AND GAS LEASE.

THIS AGREEMENT, Made and entered into this 26th, day of February, A. D. 1909, by and between Laura Wright, as guardian of Roosevelt Right, a minor Freedman, party of the first part and the Lucas Oil Company, party of the second part:
