## PARTY WALL AGREEMENT.

THIS AGREEMENT, Made on the 19 day of February, 1909, between Britton-Upp Grocery Company a corporation of the City of Tulsa, Oklahoma, party of the first part, and O. C. Boone, and W. R. Richie of the same place, parties of the second part:

WITNESSETH: That Whereas, Britton - Upp Grocer Company, a corporation, party of the first part, owns a parcel or tract of land, situated in the City of Tulsa, Tulsa County, State of . Oklahoma, being Fifty (50) feet off of the East end of Lots One and Two (1 & 2) in Block Sevent Four (74) in said City of Tulsa, Tulsa County, State of Oklahoma, being the same land conveyed to it by Erasthus H. George and Lizzie George, by deed dated the 23rd, day of January,1908, and recorded in the office of theRegister of Deeds, of Tulsa County, State of Oklahoma, in Deed Record No.35, on Page 190, and the parties of the second part own a parcel of land adjoining said first mentioned parcel, and running next to the same, the boundary line between the two parcelsorftrands of land being 50 feet, from in side sidewalk line on Detroit Street, and parallel with said Street, and

WHEREAS, said parties are desirous that a party wall should be erected on the boundary line aforesaid.

NOW, THEREFORE, said parties have mutually agreed as follows:

That the party of the first part shall erect and construct a party wall upon the boundary line between the two-parcels, one-half of said wall on each side thereof, and such depth as such first party shall see fit, and of 18 inches in thickness, of good material and workmanship
