WARRANTY DEED.

STATE OF OKLAHOMA. COUNTY OF TULSA.

THIS INDENTURE, Made and entered into ^{the} the 19th, day of November, A. D., 1908, by and between the Tulsa Heights Company, a corporation duly chartered and doing business under the laws of the Indian Territory, U. S. A., before the same became a part of the State of Oklahoma and now continuing business under and by virtue of such incorporation within the State of Oklahoma, as by law provided, with its home Office and principal Place of Business at Tulsa, Tulsa County, Oklahoma, by and through its attorney in Fact C. W. Demming, as the first party and Estate of H. L. Morrison, of Montgomery County and State of Tennessee, as the second parties.

WITNESSETH; THAT THE FIRST PARTIES FOR AND IN CONSIDERATION OF THE SUM OF ONE HUNDRED Twenty Five & no/100 Dollars, cash to it in hand paid at or before the sealing and delivery of these presents, the receipt of which is hereby confessed, has granted, bargained, sold, conveyed and confirmed and does hereby grant, bargain, sell, convey and confirm unto the second party, their heirs and assigns forever, all the following described real property and premises lying and being in the County of Tulsa, and State of Oklahoma and more particularly described as follows:

Lot No. 612 in Block No. 47.

All the above and foregoing being in Tulsa, Heights, as appears by the plat of the same on file in the office of the Register of Deeds, Tulsa County, Oklahoma. Said Tulsa Heights is laid out and platted upon the West Half of the Southwest Quarter ^{and the southeast} of the Northwest Quarter of Section Twenty Nine (29), Township Twenty (20) North, and Range Thirteen (13) East of the Indian Base and Meridian.
